DIRECTORS' FIT AND PROPER POLICY

1. INTRODUCTION

Pursuant to Paragraph 15.01A of the Main Market Listing Requirements (“**MMLR**”) of Bursa Malaysia Securities Berhad (“**Bursa**”), the Board of Directors (“**Board**”) of Seng Fong Holdings Berhad (“**Seng Fong Holdings Berhad**” or “**Company**”) has framed and adopted the Directors’ Fit and Proper Policy (“**Policy**”).

Seng Fong Holdings Berhad and its subsidiaries (collectively referred to as the “**Group**”) are committed to ensuring that directors' appointment and reappointment are based on objective criteria, merit and with due regard for diversity in skills, experience, age, cultural background and gender. Each director must have the character, experience, integrity, competence and time to effectively discharge his/her role as a director.

This Policy shall serve as a guide to the Nomination Committee and the Board in their review and assessment of candidates that are to be appointed onto the Board as well as directors who are seeking for re-election. The Nomination Committee shall assess the fitness and suitability of the person before his/her appointment or reappointment as a director, based on the criteria set out in Section 2.

2. FIT AND PROPER CRITERIA OF DIRECTORS

2.1 Character and Integrity

Probity

- Is compliant with legal obligations, regulatory requirements and professional standards.
- Has not been obstructive, misleading or untruthful in dealings with regulatory bodies or a court.

Personal Integrity

- Has not perpetrated or participated in any business practices that are deceitful, oppressive, improper (whether unlawful or not) or otherwise reflect discredit on his professional conduct.
 - Service contract (i.e. in the capacity of management or director) had not been terminated before due to concerns about personal integrity.
 - Has not abused other positions (i.e. political appointment) to facilitate government relations for the company in a manner that contradicts the principles of good governance.

Financial Integrity

- Manages personal debts or financial affairs satisfactorily.
- Demonstrates ability to fulfil personal financial obligations as and when they fall due.

Reputation

- Is of good reputation in the financial and business community.
- Has not been the subject of civil or criminal proceedings or enforcement action in managing or governing an entity for the past 10 years.
- Has not been substantially involved in the management of a business or company which has failed, where that failure has been occasioned in part by deficiencies in that management.

2.2 Experience and Competence

Qualifications, training and skills

- Possesses education qualification relevant to the skill set that the director is earmarked to bring onto the boardroom (i.e. a match to the board skill set matrix).
- Has a considerable understanding on the business and the workings of a corporation.
- Possesses general management skills as well as understanding of corporate governance and sustainability issues.
- Keeps knowledge current based on continuous professional development.
- Possesses leadership capabilities and a high level of emotional intelligence.

Relevant experience and expertise

- Possesses relevant experience and expertise with due consideration given to the past length of service, nature and size of business, responsibilities held, number of subordinates, reporting lines, and delegated authorities.

Relevant past performance or track record

- Had a career of occupying a high-level position in a comparable organization and was accountable for driving or leading the organisation's governance, business performance or operations.
 - Possesses commendable past performance record as gathered from the results of the board effectiveness evaluation.

2.3 Time and Commitment

Ability to discharge role having regard to other commitments

- Able to devote time as a board member, having factored in other outside obligations, including concurrent board positions held by the director across listed issuers and non-listed entities (including not-for-profit organisations).

Participation and contribution to the board or track record

- Demonstrates willingness to participate actively in board activities.
- Demonstrates willingness to devote time and effort to understand the business and exemplifies readiness to participate in events outside the boardroom.
- Manifests passion in the vocation of a director.
- Exhibits the ability to articulate views independently, objectively and constructively.
- Exhibits open-mindedness to the views of others and the ability to make a considered judgment after hearing the views of others.

3. REVIEW OF THE POLICY

This Policy shall be reviewed by the Nomination Committee every three (3) years or as required when internal or external events warrant a more frequent review to be undertaken.

This policy was reviewed and approved by the Board on 9 October 2024 and is made available for reference on the Company's website.
